




HIGHLIGHTS

Project Steering Committee Meeting (PSC)

On 12 January 2021, second Project Steering Committee Meeting (PSC) was held virtually. The meeting was chaired by Mr. Ghufran Memon, Federal Secretary, Ministry of National Food Security and Research. In the meeting, the progress of PAFAID was reviewed, the second progress report was validated, and planned activities for the first half of the year. The Chair appreciated the role of the Government of Japan and UNIDO for their support for the agriculture sector in Pakistan, contributing to improving the livelihoods of actors involved in the selected value chains in KP and Balochistan. HIGHLIGHTS OF MEAT VALUE CHAIN IN KP


Stakeholders Working Group Meeting for Meat Value Chain

First PPP stakeholders working group meeting for meat value chain (SHWG) was held virtually on February 24, 2021, in KP. The project's status, technical documents, and reports for the cattle meat value chain were shared in the meeting. Mr. Israr Khan Agriculture Khyber Secretary Pakhtunkhwa, chaired the session which was attended by major stakeholders including provincial government representatives and potential partners which includes MFTRO and MAFRSK.

Assessment of slaughterhouses to improve Meat Value Chain

An initial assessment of eight selected slaughterhouses in three districts of KP province namely Peshawar, Abbottabad and Dera Ismail Khan was carried out. The findings and recommendations warranted an environmental assessment too. An environmental

assessment of slaughter houses in Peshawar was also conducted to help the LCB KP for upgrading the facility to ISO 14001:2015 standards.





Advisory support for food safety policy regulatory framework

Technical opinion to develop bylaws for setting-up slaughterhouses and its operations was provided to the government of KP. This opinion supports the development of enabling regulatory practices for food safety regulatory framework and to help achieve international standards of safety and quality, and for facilitation of meat business operations, contributing to investments in the sector. This will positively impact overall performance and reputation of meat production practices in the province.







Development of Good Hygiene Practices and Good Animal Husbandry Practices Guides

From January to May 2021, Hygiene Practices (GHP) and Good Animal Husbandry Practices (GAHP) guides were developed in consultation with the L&DD, KP Food Safety and Halal Food Authority (KPFSHFA) and Local Council Board KP with the support of international experts of UNIDO. GHP and GAHP should be used by LDD and KPFSHFA for food safety

compliance. These document provide advice on Hygiene standards reducing the risk of meat contamination and how to improve the workers management and the production system. All the advices given in these manuals have the final goal to increase the beef production and improve the meat quality at the end of the chain in KP province

HIGHLIGHTS OF APPLE VALUE CHAIN IN BALOCHISTAN

PAFAID Developed Good Agricultural Practices Guide for Apple Value Chain

On 16 February 2021, a concluding ceremony to present "Good Agricultural Practices (GAP) guide for the Apple Value Chain" was held in Quetta. The GAP guide is prepared by UNIDO in consultation with the Department of Agriculture Balochistan and other public and private stakeholders.

Chief guest Engineer Zmarak Khan Achakzai, the Provincial Minister for Agriculture Government of Balochistan, appreciated the efforts of UNIDO and JICA in Pakistan and said that, "the support from UNIDO in the development of the Apple Value Chain in seven districts of Balochistan will have a profound effect on the livelihood of people".



Improving the education standard in Balochistan Agriculture College

In January- March 2021, UNIDO, the PAFAID initiative assessed the Food Technology Program of the Balochistan Agriculture College (BAC) based on European educational standards in food science. The outcome report was shared with the BAC, which identifies potential

areas for investment that will help the college upgrade its Food Sciences Program as part of its effort to become an accredited university program.



Apple Value Chain Development and Investment Strategy and Road Map for Balochistan

In consultation with key stakeholders, UNIDO initiated the development of Apple Value Chain Investment Strategy and Road Map for Balochistan, which will serve as a guiding document for a Public-Private Partnership (PPP) platform for the apple value chain in Balochistan. In March 2021, regular coordination and correspondence were held with FAO and UN/ITC. UNIDO regularly participates in meetings to discuss possible synergies related to apple value chain development in the province.



PPP Platform for Apple Value Chain Development in Balochistan

A PPP platform for Apple Value Chain Development in Balochistan was formed which includes representation Government departments, Balochistan Food Authority, BAC, Apple Farmer Association, whole-sellers. transporters, cold storage owners. Chamber Commerce and Industries Balochistan, women entrepreneurs and youth, Small and Medium **Enterprises** Development Authority, industry association, and relevant UN agencies. This platform enables development of Apple value chain in Balochistan at large, from developing technical guidelines to developing policies, strategies and ensuring inclusive and sustainable development.
